BUDGET OFFICE Carrie Cravens, Budget Director had nothing to report.

CODES Codes Administrator Robert Craig was absent from the meeting.

PUBLIC WORKS Bill Sizemore, Chairman of the Public Works Committee announced if you still have storm debris you may place it at the curb or take it out to the city garage.

Tom Somers, Public Works Director stated we will pick up vegetation only, no building materials with storm debris.

PUBLIC IMPROVEMENT Marilyn Ruppel, Chairman of the Public Improvement Committee had nothing to report.

PUBLIC SAFETY Quinn Laird, Police Chief stated in their report was 549 calls, 79 reports written and 29 arrests. They will be forming a street crimes unit, changing tactics and going after lower level drug problems.

Shawn Priddy, Fire Chief stated Marion FD put in a request for monies from the Harrison Bruce Foundation and included Herrin and Carterville for fire prevention items.

David Shoemake, Chairman of the Public Safety Committee had nothing to report.

LIBRARY Marilyn Ruppel, Liaison for the Herrin City Library had nothing to report.

CIVIC CENTER Scott Kinley, Liaison for the Herrin Civic Center was absent from the meeting.

MAYOR'S AWARD Mayor Frattini presented a Mayor's Award to Elliott Smith, Preston Lerner and Carson Coriasco for placing themselves in harm's way while rescuing a man from Kincaid spillway.

AUTHORIZE PURCHASE OF LOT Motion made by Alderman Ruppel, seconded by Alderman Shoemake to authorize purchase of lot in the 400 Block on N. Park Avenue. Monies have been donated by Harrison Bruce Foundation. Alderman Ruppel, Sizemore, Shoemake, York, Crompton and Miller voted "Yea".

RESOLUTION 11-2018 USE OF FUNDS Motion made by Alderman York, seconded by Alderman Miller to pass Resolution 11-2018 Use of TIF Funds for Hot Mix Asphalt of Various Routes. Alderman Shoemake, York, Crompton, Miller, Ruppel and Sizemore voted "Yea". None voted "Nay".

MAYOR The new police street crimes unit will help address our community's problems. We will still participate in SIEG for larger problems.

COUNCIL Alderman Crompton thanked the public works employees for their hard work during the heat. Also thanks to the police department for the new street crimes unit. Alderman Sizemore asked about E. Clark Trail, asked when it becomes county. The Calcaterra property is City limits. There is a section that is County and we will be addressing our portions with the recent resurfacing resolution.

PUBLIC Rob Newman stated that they had a bad eviction on S. 16th Street. He is thankful and happy to hear about the new crimes unit formation coming soon.
