Laura Miller works at the library and a volunteer at Herrin animal control. One of the reasons that animal control received a no-kill designation from the recuses is because they are part of a rescue network. The person over the rescue network is asking for \$10 per post. Euthanizing costs \$30-\$60. Just a reminder that we are licensed as an animal control facility.

Carrie Cravens stated she was attacked in her own yard by a pit bull. She had 3 puncture wounds, her dog didn't fair well, but hopefully will not lose her leg. Dispatch was fantastic in getting EMS to her, patrolman and animal control fantastic as well. Carrie will be pushing for dog that bit to be euthanized. If not for her protecting her dog, her dog would have died. Dog was not vaccinated; dog is vicious and will most likely attack again. We need to take a look at our animal control codes. These people are illegally breeding pit bulls. Codes need tightened up.

Rima English from South 22nd Street stated the neighborhood has tried to save a dog from there area. Animal control says dog has shelter and food. He does not have food or shelter. He's in a plastic crate that is no longer in one piece. He is tied to a tree. Barely feed or water him. He's a German shepherd. Alderman Miller has visited this residence a few times. We have some issues both sides with animal control, definitely need to bring up our ordinances.

COUNCIL

Alderman Crompton appreciates reiterating that we are not an animal control shelter or rescue. We are animal control period. We need to address vicious dogs not breed specific. We have to enforce and not being so set on sheltering and saving these animals. We need to get control of the animals.

Alderman York reminded everyone that next Tuesday is election day.

Alderman Ahlgren stated it is school board election as well. There are people confusing Herrin Feline Fixers with Herrin Animal Control.

Alderman Sizemore stated Wednesday, May 21 is pre-Herrinfest warm up. Close 100 block E. Walnut from noon to 11 p.m. He would like explanation of phone expenses later. He stated he has sat next to Alderman Ruppel for the last 26 years and will miss her.

Alderman Miller stated he hopes council will take all of the animal control topics to heart and make changes.
