

ORDINANCE NO. 8-2024

AN ORDINANCE AUTHORIZING THE EXECUTION OF THE IMLRMA  
MINIMUM/MAXIMUM CONTRIBUTION AGREEMENT


WHEREAS, the City of Herrin, a member in good standing of the Illinois Municipal League Risk Management Association and party to the IMLRMA Intergovernmental Cooperation Contract, has been fully apprised of the IMLRMA Minimum/Maximum Contribution Agreement which amends and supplements the IMLRMA Declarations pages dated January 01, 2025 to January 01, 2026 and all endorsements thereto.

WHEREAS, the City Council of the City of Herrin finds it to be in the best interest of the municipality to make its IMLRMA contribution in accordance with the IMRLMA Minimum/Maximum Contribution Agreement.

BE IT ORDAINED by the City Council of the City of Herrin and Mayor Steve Frattini:

1. That the execution of the IMLRMA Minimum/Maximum Contribution Agreement for a one year period beginning January 01, 2025 to January 01, 2026 is hereby authorized.
2. That the Mayor and Treasurer/Comptroller are hereby granted authority to execute the IMLRMA Minimum/Maximum Agreement which amends and supplements the IMLRMA Declaration pages dated January 01, 2025 to January 01, 2026 and all endorsements thereto.
3. That this ordinance shall take effect immediately upon its passage and approval.


