ORDINANCE 5-2025

AN ORDINANCE TO ANNEX CERTAIN REAL PROPERTY TO THE CITY OF HERRIN, ILLINOIS

Whereas, there has been presented to the City of Herrin, Illinois, a Petition for Annexation (Exhibit "C") of real property contiguous to the City, by the owners of the property, Williamson County Airport Authority; and

Whereas, the real property to be annexed and described in the Legal Description, attached hereto as Exhibit "A" and the Plat of Annexation attached hereto as Exhibit "B", is not within the corporate limits of any municipality but is contiguous to the City of Herrin; and

Whereas, annexation of the described real property is appropriate and authorized pursuant to Section 5/7-1-8 of the Municipal Code (65 Illinois Compiled Statutes 5/7-1-1(2010); and

Whereas, after consideration of the question of annexation, the City Council of the City of Herrin, Illinois has determined that it is in the best interests of the City that the real property specifically described in the Legal Description attached hereto as Exhibit "A" and the Plat of Annexation attached hereto as Exhibit "B" be annexed and become part of the City of Herrin.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HERRIN, ILLINOIS, AS FOLLOWS:

- Section 1. The Petition, filed by the owners of certain property for the annexation of territory to the City is hereby granted.
- Section 2. The real property, specifically described in the Legal Description attached hereto as Exhibit "A" and the Plat of Annexation attached hereto as Exhibit "B", and made part of this ordinance by reference, is hereby annexed to the City of Herrin, Illinois.
- Section 3. The real property described herein in Exhibits "A" & "B" is zoned A-1 Agricultural, as that zoning district is described in the City's existing zoning ordinance.
- Section 4. A certified copy of this Annexation Ordinance, together with the Plat of Annexation, shall be recorded in the Office of the Recorder, Williamson County, Illinois.
- Section 5. This Ordinance shall be in full force and effect from and after its passage, approval and recording in accord with law.
- **Section 6.** This Ordinance is passed pursuant to the home rule authority of the City of Herrin, Illinois.




