#### ORDINANCE 5-2024

### AN ORDINANCE AMENDING CHAPTER 24, SCHEDULE "A" OF THE HERRIN REVISED CODE OF ORDINANCES

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HERRIN, ILLINOIS, AS FOLLOWS:

Section 1. That in Chapter 24, Schedule "A" the following changes be made:

TWO-WAY STOP INTERSECTIONS. Add the following:

Through Street		Stop Street(Directions)		
Indian Hill Dr.	at	Hilldale Ave.(Both)		

Section 2. This Ordinance is intended to and shall be in addition to all other Ordinances, rules and regulations concerning traffic, parking and use of street; and shall not be taken to repeal any other Ordinance or part of any other Ordinances unless in direct conflict therewith.

Section 3. This Ordinance shall be in full force and effect from and after its passage and approval in the manner provided by law.

Section 4. This Ordinance is passed pursuant to the Home Rule Authority of the City of Herrin, Illinois.
