#### **ORDINANCE 6-2025**

# ORDINANCE AMENDING CHAPTER 15, ARTICLE II, SECTION 1, SUBSECTIONS (J) & (L) OF THE HERRIN REVISED CODE OF ORDINANCES

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HERRIN, ILLINOIS AS FOLLOWS:

**Section 1.** That the following section be amended:

# 15-2-1 <u>Compensation for Department Directors & Employees</u> ([) Animal Control Warden I

Hourly Rate: \$19.00/hour. Employee must work a 40-hour work week. Time worked over 40 hours per week will be paid at a rate of one and one-half (1  $\frac{1}{2}$ ) times the normal rate.

\*ALL OTHER INFORMATION IN THIS SUBSECTION IS TO REMAIN UNCHANGED AT THIS TIME.

### (L) Animal Control Warden II

Hourly Rate: \$18.00/hour effective May 1, 2025. Employee must work a 40-hour work week. Time worked over 40 hours per week will be paid at a rate of one and one-half (1 ½) times the normal rate.

\*ALL OTHER INFORMATION IN THIS SUBSECTION IS TO REMAIN UNCHANGED AT THIS TIME.

<u>Section 2.</u> This ordinance shall become effective upon its passage, approval and publication in accord with law.

<u>Section 3.</u> This ordinance is passed pursuant to the home rule authority of the City of Herrin, Illinois.
