ORDINANCE NO. 12-2024

ORDINANCE ABATING GENERAL OBLIGATION BONDS (WATER SYSTEM REVENUE PLEDGE), SERIES 2017 TAX LEVY FOR THE TAX YEAR 2024

WHEREAS, THE CITY OF HERRIN adopted Ordinance No. 9-2017 on May 22, 2017 which ordinance authorized the issuance of General Obligation Bonds (Water System Revenue Pledge), Series 2017 pursuant to the provisions of Section 8-4-1 (13) of the Illinois Municipal Code: and

WHEREAS, said bonds are General Obligation Bonds (Water System Revenue Pledge), Series 2017 of the City of Herrin; and

WHEREAS, the sum of \$81,200.00 provided in said ordinance to be levied for the tax year 2024; and


WHEREAS, the City has on hand sufficient sums of money to pay all bond, principal and interest costs coming due, in lieu of said tax levy; and

WHEREAS, it is the desire of the City Council and Mayor of the City of Herrin to abate taxes and offer relief to tax payers whenever possible.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HERRIN AS FOLLOWS:

1. That the tax levy for General Obligation Bonds (Water System Revenue Pledge), Series 2017 pursuant to Ordinance No. 9-2017 of the City of Herrin for the tax year 2024 in the sum of \$81,200.00 is here abated.
2. That the Clerk is hereby directed to file a copy of this ordinance with the County Clerk of Williamson County , Illinois notifying him of the abatement of said General Obligation Bonds (Water System Revenue Pledge), Series 2017 be removed from the computation of tax rates for property located within the City of Herrin for the year 2024 bills.
3. That it is the intention of the City Council and Mayor of the City of Herrin that this ordinance and every provision thereof shall be considered separable, and the invalidity of any portion of this ordinance shall not affect the validity of any other portion of this ordinance.
4. That this ordinance shall be known as Ordinance No. 12-2024 of the ordinances of the City of Herrin, Illinois, and shall be in full force and effect from and after its passage, approval, recording and publication in accordance with law.



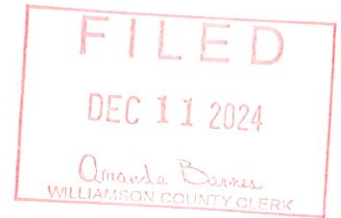


