# ORDINANCE AMENDING CHAPTER 15, ARTICLE II, SECTION 1, SUBSECTION (L) OF THE HERRIN REVISED CODE OF ORDINANCES

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HERRIN, ILLINOIS AS FOLLOWS:

**Section 1.** That the following section be amended:

# 15-2-1 <u>Compensation for Department Directors & Employees</u> (L) Animal Control Warden II

Add the following language:

\*Effective with the pay period beginning January 15, 2025, the person(s) in this position shall receive a \$1.00 per hour raise.

ALL OTHER INFORMATION IN THIS SUBSECTION IS TO REMAIN UNCHANGED AT THIS TIME.

**Section 2.** This ordinance shall become effective upon its passage, approval and publication in accord with law.

<u>Section 3.</u> This ordinance is passed pursuant to the home rule authority of the City of Herrin, Illinois.
